


ADVOCATE NIVEDITA CHAUHAN, HON'BLE SUPREME COURT OF INDIA



POCSO ACT, 2012 (PROTECTION OF CHILDREN FROM SEXUAL OFFENCES ACT)

The POCSO Act, 2012, is a comprehensive law in India that safeguards children from sexual abuse, sexual harassment, and pornography. It defines a child as anyone under the age of 18 and provides for child-friendly procedures during investigation and trial to ensure the victim is not re-traumatized. The Act mandates timely reporting, special courts for speedy trials, and strict punishments to deter offenders. It recognizes both boys and girls as victims and emphasizes the importance of protecting children's dignity and privacy throughout the legal process.

PROTECTION OF WOMEN FROM DOMESTIC VIOLENCE ACT, 2005

The Domestic Violence Act, 2005, provides a civil remedy for women facing physical, emotional, sexual, verbal, or economic abuse within domestic relationships. It empowers women to seek protection orders, residence rights, and maintenance through the court, with the help of Protection Officers and service providers. Unlike traditional criminal laws, this Act is preventive and remedial in nature, aiming to provide immediate relief and long-term support to spouses within the home environment.




PROHIBITION OF CHILD MARRIAGE ACT, 2006

The Prohibition of Child Marriage Act, 2006, aims to eliminate the harmful practice of child marriage in India. It sets the minimum legal age of marriage at 18 for girls and 21 for boys. The Act declares child marriages voidable at the option of the minor and prescribes punishments for those who perform, abet, or solemnize such marriages. The law plays a crucial role in protecting children, especially girls, from early pregnancies, school dropouts, and a lifetime of disempowerment.

CONSTITUTIONAL RIGHTS OF WOMEN - ARTICLES 14, 15, 17, AND 21

The Constitution of India guarantees fundamental rights that uphold women's dignity, equality, and freedom. Article 14 ensures equality before the law and equal protection of the laws. Article 15 prohibits discrimination on the grounds of sex, and allows the state to make special provisions for women and children. Article 17 abolishes untouchability, ensuring social inclusion, and Article 21 guarantees the right to life and personal liberty, interpreted to include the right to live with dignity, safety, and freedom from violence. Together, these provisions form the bedrock of gender justice and empowerment in India.
